



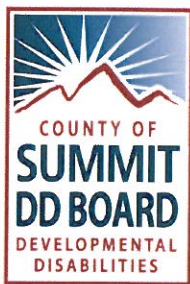

Endorsement of Akron Public Schools Levy – Issue 14

Mr. Quade moved that in consideration of the impact that appropriate school funding for the Akron Public Schools has on the delivery of services to more than 10% of persons living with developmental disabilities served by the Summit County Board of Developmental Disabilities;

Resolved that the Summit County Board of Developmental Disabilities hereby endorses the Akron Public Schools Issue 14 ballot initiative, appearing on the November 8, 2011 ballot, and further authorizes the Superintendent to sign any official forms required to communicate this endorsement. The motion, seconded by Mr. Briggs, was unanimously approved.
