A majority affirmative vote is necessary for passage.

An additional tax for the benefit of the Akron City School District for the purpose of current expenses at a rate not exceeding 7.9 mills for each one dollar of valuation, which amounts to 79 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2006, first due in calendar year 2007.
